# 1. Understand the New Quality Measures

The HQRP now consists of four Quality Measures (QMs):

Consumer Assessment of Healthcare Providers and Systems (CAHPS®) Hospice Survey



Measures caregiver experience of hospice care

Hospice Visits in Last Days of Life (HVLDL)



Measures care processes during the last three days of life before discharge 4

**Hospice Care Index (HCI)** 



Measures care processes throughout the hospice stay

## 2. Create Your Game Plan

When preparing for 2022 it's important to note key dates and deadlines which can be found here. Below are two tips to keep in mind when creating your game plan.





Providers have
4.5 months

following the end of each calendar year (CY) quarter to review and correct their HIS records with target dates in that quarter for public reporting.

Updates made after the correction deadline will NOT appear in any subsequent Care Compare refresh.

# 3. Team Participation

Beyond the providers, it's important to identify your key stakeholders who contribute to your overall performance. With public reported measures and consumer surveys, each team member in your hospice facility impacts your outcome.

## 4. Future Penalties to Note

The next update to CMS' Annual Payment Unit (APU) is coming in 2024 and will increase the FINANCIAL PENALTY FOR NONCOMPLIANCE from 2% to 4%.

While that may seem like plenty of time to improve your quality measures, the 2024 APU will be based on information from the CY 2022 REPORTING PERIOD.
